## **HEALTH REQUIREMENTS**

Swine must have an official health certificate, or an official test chart showing a Negative Pseudo rabies test and Brucellosis conducted after December 1, 2022. Swine that originate from a Qualified Pseudo rabies Free Herd may be exempt from the test, provided they are being exhibited by direct family members of the Owners of that Qualified Pseudo rabies Free Herd. Any animal may be removed from the show by members of the individual Species Committee, if found to have any contagious disease or condition. All sheep and goats must abide by state regulations for Scrapies.

## **GENERAL RULES AND REGULATIONS**

### **1. INTERPRETATIONS, AMENDMENTS, AND VIOLATIONS**

The Creek County Fair Board reserves the final and absolute right to interpret all rules and regulations in this premium book, and arbitrarily settle and determine all matters, questions and differences in regard thereto or otherwise arising out of, connected with, or incident to the Show. The Fair Board reserves the right to amend or add to these rules as they, in their judgment, deem necessary.

### **2. SHOW RING CODE OF ETHICS.**

Believing it is in the best interest of all breeders of all livestock to maintain a reputation of integrity and to continue to present a wholesome and progressive image in the show ring, the following list of practices are considered unacceptable and a violation of the Rules and Regulations of this show;

- Misrepresenting the age of any animal.
- Treating or massaging any part of the body of an animal, internally or externally with an irritant, counter-irritant, or any other substance to temporarily straighten a weak back or loin or to produce unnatural animation.
- Feeding or injecting drugs, depressants or applying packs or using any artificial contrivance or therapeutic treatment except normal exercise is against the rules.
- Striking the animal to cause swelling.
- Surgery or any other procedure performed to change the natural process of growth, maturation, contour or appearance of any animal, to include teeth, is prohibited. Not included is the removal of teats or horns, castration, clipping and dressing of hair and trimming of hooves.

- Any attempt to change natural color of an animal at the show, by changing the color or adding false hair, fleece or skin at any point or area of the animal, unless exempted in the individual species rules.
  - The use of alcoholic beverages in the feed or administered as a drench is expressly prohibited.
  - The practice of artificial filling internally or by pumping or any other device is prohibited unless otherwise specified by the species rule.
  - Administration of a drug internally or externally, prior to entering the show ring, except for treating a recognized disease or injury, or tranquilizing females in heat. The use of any chemical and/or compound that is not approved by the Food and Drug Administration for use in meat producing animals and the illegal use of approved chemicals or compounds are prohibited. All animals are subject to tests for foreign substances that exceed the acceptable levels established by the USDA, FDA or EPA. A positive test will result in disqualification, forfeiture of any premiums and/or awards and will exclude the exhibitor from future competition at the Creek County Livestock Show. All exhibitors shall follow label guidelines and adhere to withdraw times for any medications administered prior to or during the show.
  - Criticizing or interfering with the judge, other exhibitors, breed representatives, or show officials before, during, or after the event.
  - Any violation of the Rules and Regulations may result in forfeiture of all premiums and awards, disqualification of entry, expulsion or probation of the exhibitor, organized group, and individual or livestock involved. All disciplinary actions of the Management will be final. Such action will require application for readmission under terms the Management may prescribe before the group or individual is allowed to exhibit at future events. Anyone (including, but not limited to Exhibitors, Ag Teachers, Parents, Friends, and Relatives) involved with livestock exhibited at the Creek County Livestock Show is to abide by the Rules and Regulations of the show. Violators will be disciplined by the fair board.
3. The individual Species Committee will have the right and duty to interpret and act on any violation of the rules. Two of the Species Committee members can act to disqualify any exhibit in which a rule violation has occurred. The decision of that committee will be final.
  4. **Livestock must be shown by the exhibitor listed on the entry card, in class, as well as sale order.** Any exemptions to this rule must have prior approval by the individual Species Committee, except in the case of an exhibitor having multiple animals in the class or sale order drive. Violations to this rule will result in the

animal being pulled from the class and/or sale order. The animal will be disqualified.

5. The exhibitor must own and have in possession all livestock according to the following dates:

Market Steers	-	November 9, 2022
Sheep/Goats	-	November 9 2022
Swine	-	December 9, 2022
Heifers	-	January 20, 2023
Prospect Steers	-	January 20, 2023

- 6 All animals must be available for verification site visits by the Fair Board. If animals are not in possession, exhibitor will be brought before the Fair Board for further action.
7. No livestock can be replaced after the ownership dates nor nominations be changed after the ownership dates. Animals may be nominated by family with designation of individual at show.
8. Exhibitors must be a 4-H or FFA member in good standing and must be a resident of Creek County or attend a Creek County School to be eligible to show. Exhibitor must be at least 7 years old by the first day of the Livestock Show. All exhibitors must be an active member in the Creek County 4-H and/or FFA programs and must be a primary resident of or attend school in Creek County to be eligible to show.
9. An exhibitor or animal may not show in more than one County Livestock Show in Oklahoma in any one year.
10. Animals may only be entered and shown in one division.
11. Designation of FFA Chapter or 4-H Club will be required on the pre-entry form. This designation will be final. No changes allowed.
12. Any exceptions to any rule will be decided by the Species Committee.
13. Exhibitors will not be allowed to stay overnight in barns.
14. All livestock must remain inside the main arena and be in their assigned area at the designated times found in the schedule of events and remain in place until the conclusion of their species. Any exhibitor who violates this rule will have any exhibits banned from the Premium Sale and will forfeit any and all prize money won.
15. No additional pens will be built after pen assignments are made.
16. This Show is a part of a Youth Educational Program; therefore, the exhibitor must be involved with the grooming and care for their own animals.

17. It is the responsibility of all exhibitors, parents, family, and friends to know and abide by the Rules and Regulations of this show. Violations will not be excused because of someone not being informed of all Rules.
18. **INJURED ANIMAL:** When the judge determines an animal can no longer compete without endangering itself, said animal will be disqualified, and the next highest placing animal in that class or preliminary sale order will be brought in to replace the disqualified animal.
19. **EXHIBITORS DRESS CODE:** FFA official jacket and shirt with collar. 4-H white shirt with collar with emblem or 4-H green jacket. Blue or black jeans, slacks, or skirts for Show & Sale. 7 & 8-year olds – jeans and white shirt. A buttoned up, collared shirt, short or long sleeve of the appropriate 4-H colors or solid green, solid white, or a mix of green and white; or FFA colors of solid blue, solid yellow, or a mix of blue and yellow. NO THIRD COLOR MIX, OR ADDITIONAL COLORS ARE ALLOWED. Must have an official 4-H or FFA emblem of at least 2 ½ inches. The show ring dress code will also be enforced during the premium sale. No headgear is allowed, with the exception of cowboy hats and bows.
20. **PROTESTS:** A protest (in writing) on rules violations will be accepted by the Species Committee along with a \$100 cash deposit. If rule infraction is validated the \$100 will be refunded. Protests will be accepted from beginning of the show on Tuesday up to the start of the Premium Sale.
21. **SHOWMANSHIP:** There will be four (4) classes of Showmanship in each species – Pre-Junior – 2<sup>nd</sup> grade and under; Junior – 3<sup>rd</sup> – 6<sup>th</sup> grades; Intermediate – 7<sup>th</sup> – 9<sup>th</sup> grades; and Senior – 10<sup>th</sup> – 12<sup>th</sup> grades. Each class winner will receive a jacket. Each division winner will then compete for the overall species showmanship award. This winner will receive a belt buckle and will be presented at the Premium Sale at 6:45 p.m. If you want to go to Oklahoma Youth Expo you must be at least 8 years old, in the 3<sup>rd</sup> grade and win Showmanship Division for Cattle or Swine.
22. **COUNTY BRED CLASSES:** Each species will be allowed a county bred class. Animals must be born to a Creek County Resident or within Creek County. Minimum of three (3) county bred entries are needed to make a county bred class. Animals cannot be shown in both Breed classes and County Bred classes. Owner must have registration papers or a letter from the breeder indicating that the animal is County Bred at weigh-in. The letter must be signed by Ag teacher or 4-H leader and exhibitor. \*\*See page 9 for Certification Form

**\*\*\* Discussion on the next year's Livestock Show Judges will take place at the Fair Board Meeting on the 2<sup>nd</sup> Thursday of April following the livestock show.**

## **PREMIUM SHOW**

1. Only one animal may be sold by an exhibitor in the Premium Sale per year.
2. An animal may only sell in the Premium Sale once in its lifetime and would not be eligible for exhibition the following year.
3. Each exhibitor selected for the Premium Sale is required to attend and exhibit their animal in the sale ring. Failure to attend the Premium Sale will result in forfeiture of Premium money. Extreme emergencies may be grounds for exemption to this rule, but only with the prior approval of the Fair Board.
4. All exhibitors should write thank you notes to Buyers and Donors.
5. The duty of tearing down the panels from the Premium Sale will belong to each community under the direction of its Agriculture Education teacher on a rotational basis. This will be done in a timely fashion.

### **PREMIUM SALE**

#### **Tuesday, March 7, 2023 FAIR FACILITY ARENA**

Forty-Four (44) market hogs, eleven (12) market steers, fourteen (14) market lambs, and sixteen (16) goats will be in the auction. On all breeding animals – heifers, does, wether dams, ewes and gilts – one (1) will make the Premium Sale if 10-19 are exhibited, and two (2) animals if 20 or more are exhibited – no more than two in each category, unless otherwise specified by a species rule. If any spot or spots excluding the County Bred Heifer is left unfilled, that spot will be put into a drawing with all the divisions represented and drawn for. The first alternate from that division will move into the unfilled spot unless the Swine division is drawn. If the Swine division is drawn there will be a second drawing just among the breeds of swine to determine the alternate that will move up.

## **BEEF DIVISION**

**Beef Committee: Darin Toliver, Perry Collins, Terry Spencer  
and Rashele Blakley**

### **BREEDING BEEF**

Nomination Process: All Heifers must be owned by January 20, 2023. Proof of ownership required. (Examples: Registration papers, bill of sale, or letter from Ag Teacher or Extension Educator.) All Heifers will be nominated at the Creek County Fairgrounds on or before January 20, 2023. At Nomination all Heifers must have a tattoo that matches registration papers or bill of sale to show in a Purebred Class. All others will need a county tag. All Registered Heifers must keep the same breed designation used at the entry date. Any changes will cause the Heifer to show in commercial class.

1. All Heifers will be positively identified from the registration papers and the Creek County Nomination Forms at the Creek County Livestock Show when they are checked in by the Beef Committee.
2. Heifers must be born on or after January 1, 2021.
3. No more than 3 Heifers may be shown by any one exhibitor.
4. All registered Heifers must have registration papers listing the exhibitor as the sole owner (No Family, Ranch, or Partnership) at the check in during the Creek County Livestock Show.
5. Cattle exhibitors may use colored adhesives on similar colored hair and hoof dressing on hooves. Touch up paint is allowed as long as it does not violate General Rules Rule Number Two.
6. There must be 3 or more registered heifers of the same breed entered and eligible on the day of the show to recognize that breed in the show. If less than 3 registered heifers, they will show as AOB. All Non-Registered Heifers will show as Commercial heifers.
7. Breed classes will be broken by the Beef Committee. Registered Heifers will show by age. There will be no more than a 6-month age difference among the registered heifers.
8. Commercial Heifers will be shown by weight. Commercial heifers will be broken according to the following guidelines: 1-4 heifers – 1 class; 5-8 no more than 2 classes; 9+ - no more than 3 classes.

9. Only Grand and Reserve Grand will make the Premium Sale by the following criteria: One heifer will make Premium Sale if 10-19 heifers are exhibited; two heifers if 20 or more are exhibited. No more than 2 heifers will be sold in the Premium Auction. The judge will select sale order and alternates. (See Rule #6 under County Bred Heifers).
10. Showmanship for all cattle exhibitors will follow the conclusion of the Steer Premium Sale line up. Classes are based on the grade of the exhibitor as of the day of the show. Only exhibitors that have cattle entered in their name and exhibited by the owner are eligible. (If you just showed an animal that belonged to someone else, you CANNOT compete in showmanship.)  
Divisions are as follows:
  - Pre-Junior – 2<sup>nd</sup> Grade and under
  - Junior – 3<sup>rd</sup> – 6<sup>th</sup> grades
  - Intermediate – 7<sup>th</sup> – 9<sup>th</sup> grades
  - Senior – 10<sup>th</sup> – 12<sup>th</sup> grades
  - Overall Beef Showmanship Award

## **COUNTY BRED HEIFERS**

1. Heifers must be calved by a Creek County School District resident or calved in Creek County.
2. Heifers cannot be shown in both Breed classes and County Bred classes.
3. County Bred Champion Heifer will line up for overall Grand Champion.
4. Owner must have registration papers or a letter from the breeder indicating that the calf is County Bred at weigh-in. The letter must be signed by Ag teacher or 4-H leader and exhibitor.
5. County bred heifers will be shown by weight.
6. If five (5) or more heifers are entered in the County Bred division, the Champion County Bred heifer will be allowed in the Premium Sale as the 3<sup>rd</sup> overall heifer sold. If the Champion County Bred heifer is Grand or Reserve overall heifer, the total number of heifers in the sale will remain at two (2).

## **MARKET STEER**

Nomination Process: All Steers will be nominated at the Creek County Fairgrounds on November 9, 2022. If nominating at OYE, please use the OYE tag for county nomination. Members of the Beef Committee and Extension Ag Agent will classify all steers.

1. All steers will be positively identified with an OYE Tag or Creek County Nomination tag at the Creek County Livestock Show when they are weighed by the Beef Committee.
2. No more than 3 market steers may be shown by any one exhibitor.
3. Market steers must weigh at least 950 pounds on day of show. First weight is official, if within official limits. (Those weighing over 900 pounds will be given one reweigh). All steers weighing less than 950 pounds must show as prospects and are not eligible for the Premium Sale.
4. Mini Breeds will show in their own class(es). Minimum of three (3) head is required to make a breed class.
5. Cattle exhibitors may use colored adhesives on similar colored hair and hoof dressing on hooves. Touch up paint is allowed as long as it does not violate General Rules Rule Number Two.
6. There must be 3 or more steers of the same breed entered and eligible on the day of the show to recognize that breed in the show. If less than 3, they will show as AOB.
7. Breed classes will be broken by the Beef Committee by weight, within the following guidelines: 1-4 head – 1 class; 5-8 head – no more than 2 classes; 9 or more – no more than 3 classes.
8. The weight of the steer will be provided to the judge.
9. Twelve (12) steers are eligible for the Premium Sale.
10. After Champion and Reserve Champion of each breed are selected, the judge will line up as many steers as he/she and the Beef Committee deems necessary for a preliminary sale order.
11. Showmanship for all cattle exhibitors will follow the conclusion of the final Steer Premium Sale line up. Only exhibitors that have cattle entered in their name and exhibited by the owner are eligible. (If you just show an animal that belonged to someone else you CANNOT compete in showmanship.) Classes are based on the grade of the exhibitor as of the day of the show.

## **COUNTY BRED STEER**

1. Steers must be calved by a Creek County School District resident or calved in Creek County.
2. Steers cannot be shown in both open and County Bred classes.
3. County Bred Champion steer will line up for overall Grand Champion.
4. Owner must have a letter from the breeder to show that the calf is County Bred on Nomination Day – November 9, 2022. The letter must be signed by Ag teacher or 4-H leader and exhibitor.
5. All steers are eligible for Premium Sale and will line up for sale order. The Champion County Bred Steer will be selected for the Premium Sale in at least the twelfth slot.
6. **There must be three or more county bred steers to be guaranteed 12th slot in the sale.**

## **PROSPECT STEER**

**Prospects are not eligible for the Premium Sale. (Trophy and Ribbons) All other cattle rules apply.**

# **CREEK COUNTY PRODUCTION STEER PROGRAM (CCPSP)**

## **Objective**

To teach Creek County youth about today's beef industry through "hands on" experiences. This will be accomplished with selection, daily care and management of the steer(s) which includes: feeding the proper kind and amount of feed, preparing and showing project and following their animal through a processing plant to learn how that animal would be processed and graded in the current market.

## **Rules**

1. All steers must be born in Creek County and have been deemed "acceptable" by the CCPSP committee to be eligible for student selection.
2. All Participants are responsible for selecting and purchasing their own steers.
3. All steers will be rechecked and officially weighted for the ADG portion of the contest during the Creek County Fall Fair. (Exhibition in the Fall Fair show is optional)
4. Participants can have no more than 3 steers show in the spring livestock show. This number can be made up of steers entered in the market steer section and/or the CCPSP.
5. Steers will be shown at the Creek County Spring Livestock show (CCSLs) in the production steer class. Steers that show in the production steer class must go to the processing plant for grading. This is a terminal class.
6. Weigh out (final weight) will occur during the designated check in time for the CCSLS.
7. The production steers will also be eligible to show in the market steer show at the creek county spring livestock show (as long as they meet all needed requirements). In addition, these steers will be eligible for the premium sale according to guidelines approved by the creek county fair board if properly nominated and entered under the CCSLS guidelines.
8. The minimum weight for the production steer program at weigh out is 950 or the animal will be disqualified.
9. This program has three phases and a record book. All phases must be completed (including record book and final show) or the animal will be disqualified.
  - (a) **Average daily gain (ADG)** will be calculated from weigh in day (fall fair) to weigh out day (spring livestock show). This phase has 100 points

possible. Each steer will be assigned points based on how they compare to the high ADG steer.

- b) **Show ring placing** will be determined by the CCSLS beef judge. Points will be awarded accordingly from first to last place. All production steers will be subject to all rules governing the 2022 CCSLS. 25 points possible (if there are more than 25 steers this section of points will be adjusted up)
- c) **Carcass placing** will be determined by using the OK steer feed-out carcass index which uses carcass weight, fat cover, rib eye area, internal fat and quality grade to rank carcasses according to industry needs. Points for this phase will be the actual index value.
- d) **Record books** are due by 4 pm in the Creek County Extension office the Friday before weigh out. Point deduction penalties will be assessed on late record books. Forms and guidelines for the books will be furnished. The record book has 50 points possible.

**10. Awards**

- a) Buckles will be awarded to Grand, Reserve, and Bronze overall animals
- b) Banners will be awarded to all champion and reserve division winners

**11. Carcass sale** - The Grand overall and the champion Carcass animals will sell  $\frac{1}{2}$  of each carcass at the Creek County Premium Sale. (If this is the same animal the second place carcass animal will also sell  $\frac{1}{2}$ )

**12. Premium sale** - All production steers are eligible for the premium sale and will line up in the grand drive and for sale order

**13. It will be the goal of the Creek County Fair Board that all production steer exhibitors be provided the opportunity to view their steer at the processing facility.**

## **CATTLE FITTING CONTEST**

Creek County can send two teams to compete at the Oklahoma Youth Expo. All teams must consist of three exhibitors with eligible entries at the 2023 Oklahoma Youth Expo steer or heifer Show.

Each team must be comprised of the following regulations:

A. Each team must be comprised of three members.

B. Each team must have at least one member under the age of 13 (13 years or under on the day of the OYE contest).

### **Cattle Fitting Contest Rules**

1. Contest will be 30 minutes in length. A 10-minute warning will be given. At the end of the 30-minute allotted time, clippers down and work stopped.
2. All grooming rules will be strictly enforced.
3. The animal must be provided by the team, being an eligible entry at the 2023 Creek County steer or heifer show. The animal must also be owned by one of the team members.
4. Each animal must be completely clean and dry.
5. Students will be judged based upon the following criteria:
  - A. Quality of workmanship
  - B. Team Skills – Compatibility & Organization
  - C. Compatibility of the use of various types of clippers
6. Neatness of individuals and area will be in consideration.

The top two teams from the Cattle Fitting Contest will be entered in the 2023 Oklahoma Youth Expo Cattle Fitting Contest to be held on Monday, March 13, 2023.

Nomination Process: All Goats must be owned by November 9, 2022. All Goats will be nominated at the Creek County Fairgrounds on November 9, 2022. If nominating at OYE, please use the OYE tag for county nomination, all others will need a county tag.

1. County Bred Classes, refer to Page 7, Rule #21.
2. Does and wethers may be shown and will be placed in the same classes.
3. Goats will not be mouthed.
4. All market goats will be weighed by the Market Goat Committee and placed into class. No weigh back.
5. At the time of show, market goats must be slick shorn above the hocks and knees with the hair not exceeding a length of 3/8 inch.
6. The practice of "drenching" goats is acceptable at the Creek County Livestock Show.
7. The minimum weight for market goats is 50 pounds. The maximum weight will be 130 pounds.
8. Only Goat Committee allowed in arena. One student per goat at one time.
9. Sixteen (16) market goats are eligible for the Premium Sale. If there are 8 or more county bred market goats, the Champion County Bred Market Goat will automatically qualify for the 16th spot in the premium sale.
10. Showmanship for goat exhibitors will follow the conclusion of the final Market Goat Show. Only exhibitors that have a goat entered in their name and exhibited by the owner are eligible. (If you just show an animal that belonged to someone else you CANNOT compete in showmanship). Classes are based on the grade of the exhibitor as of the day of the show.  
Divisions are as follows:

Junior – 3<sup>rd</sup> – 6<sup>th</sup> grades

## **WETHER DAM DOE**

Nomination Process: All Goats must be owned by November 9, 2022. All Goats will be nominated at the Creek County Fairgrounds on November 9, 2022. If nominating at OYE, please use the OYE tag for county nomination, all others will need a county tag.

1. County Bred Classes, refer to Page 7, Rule #21.
2. Goats will not be mouthed.
3. All wether dam does will be weighed by the Market Goat Committee and placed into class. No weigh back.
4. An exhibitor may nominate and show three (3) wether dams in the wether dam division.
5. Exhibitors may exhibit a doe as a wether dam, breeding doe or market goat, but not in more than one division. Exhibitors do not need to designate Wether Dam, Breeding or Market at nominations nor on entry forms. Designation may be made at show check-in.
6. At the time of show, wether dam does must be slick shorn above the hocks and knees with the hair not exceeding a length of 3/8 inch.
7. The practice of “drenching” goats is acceptable at the Creek County Livestock Show.
8. The minimum weight for does is 50 pounds. The maximum weight will be 160 pounds.
9. Only Goat Committee allowed in arena. One student per goat at one time.
10. Grand and Reserve Grand may make the Premium Sale by the following criteria: one wether dam will make Premium Sale if 10-19 wether dam are exhibited; two wether dam if 20 or more are exhibited. The judge will select sale order and alternates.
11. If ten (10) or more wether dam are entered in the County Bred division, the Champion County Bred wether dam will be allowed in the Premium Sale as the 3rd overall wether dam sold. If the Champion County Bred Wether Dam is Grand or Reserve overall wether dam, the total number of wether dam in the sale will remain at two (2).

## **BREEDING DOES**

Nomination Process: All breeding does must be owned by November 9, 2022. All does will be nominated at the Creek County Fairgrounds on November 9, 2022. If nominating at OYE, please use the OYE tag for county nomination, all others will need a county tag.

1. County Bred Classes, refer to Page 7, Rule #21.
2. Does will show by weight, not age. Does will be weighed by the goat committee. Minimum weight for does will be 50 pounds and maximum weight for does will be 160 pounds.
3. Does do not have to be slick shorn to show.
4. An exhibitor may nominate and show three (3) does for the breeding division.
5. Does do not have to be registered.
6. Exhibitors may exhibit a doe as a wether dam, breeding doe or market goat, but not in more than one division. Exhibitors do not need to designate Wether Dam, Breeding or Market at nominations nor on entry forms. Designation may be made at show check-in.
7. The practice of "drenching" goats is acceptable at the Creek County Livestock Show.
8. No bracing of Breeding Does.
9. Grand and Reserve Grand may make the Premium Sale by the following criteria: one doe will make Premium Sale if 10-19 does are exhibited; two does if 20 or more are exhibited. The judge will select sale order and alternates.
10. If ten (10) or more Does are entered in the County Bred division, the Champion County Bred doe will be allowed in the Premium Sale as the 3rd overall doe sold. If the Champion County Bred doe is Grand or Reserve overall doe, the total number of does in the sale will remain at two (2).

## **DOE FITTING CONTEST**

Creek County can send two teams to compete at the Oklahoma Youth Expo. All teams must consist of two exhibitors with eligible entries at the 2023 Oklahoma Youth Expo Goat Show.

Each team must be comprised of the following regulations:

- A. Each team must be comprised of two members.
- B. Each team must have at least one member under the age of 15 (15 years or under on the day of the OYE contest).

### **Doe Fitting Contest Rules**

1. Contest will be 30 minutes in length. A 10-minute warning will be given. At the end of the 30-minute allotted time, clippers down and work stopped.
2. All grooming rules will be strictly enforced.
3. The animal must be provided by the team, being an eligible entry at the 2023 Creek County Goat Show. The animal must also be owned by one of the team members.
4. Each animal must be completely clean and dry.
5. Students will be judged based upon the following criteria:
  - A. Quality of workmanship
  - B. Team Skills – Compatibility & Organization
  - C. Compatibility of the use of various types of grooming equipment and supplies.
6. Neatness of individuals and area will be in consideration.

The top two teams from the Doe Fitting Contest will be entered in the 2023 Oklahoma Youth Expo Cattle Fitting Contest to be held on Friday, March 10, 2023.

## **MARKET LAMB**

Nomination Process: All Market Lambs must be owned by November 9, 2022. All Market Lambs will be nominated at the Creek County Fairgrounds on November 9, 2022. If nominating at OYE, please use the OYE tag for county nomination, all others will need a county tag.

1. County Bred Classes, refer to Page 7, Rule #21.
2. All Market Lambs will be positively identified from OYE Nomination tag and/or the Creek County Nomination tag at the Creek County Livestock Show.
3. No more than 3 Market Lambs may be shown by any one exhibitor. Ewes (with no visible signs of pregnancy) or Wethers may be shown.
4. Lambs will **not** be mouthed.
5. The practice of “drenching” sheep is acceptable at the Creek County Livestock Show.
6. There must be 3 or more Market Lambs of the same breed entered and eligible on the day of the show to recognize that breed in the show. If less than 3, they will show as AOB or Crossbred.
7. All Market Lambs will be officially weighed and classified for breed by the Sheep Committee. Only the exhibitor and one lamb at a time will be allowed to go before the classification committee. Their decision will be final.
8. All Market Lambs will be slick sheared.
9. The Sheep Committee will break the classes with as close to 5 or more in each class as possible.
10. There will be 14 Market Lambs in the Premium Sale. If there are 8 or more county bred market lambs, the Champion County Bred Market Lamb will automatically qualify for the 14th spot in the premium sale.
11. After Champion and Reserve Champion of each breed are selected, the judge will line up as many Market Lambs as he/she and the Sheep Committee deem necessary for a preliminary sale order.
12. Only Sheep Committee allowed in arena. One student per lamb at one time.

13. A sheep exhibitor may exhibit a Ewe as Breeding Ewe or as Market Lamb, but not both. Exhibitors do not need to designate Ewe Lambs as Market or Breeding at nomination nor on entry forms.
14. Showmanship for all Sheep exhibitors will follow the conclusion of the final Premium Sale line up. Only exhibitors that have a lamb entered in their name and exhibited by the owner are eligible. (If you just show a lamb that belonged to someone else, you CANNOT compete in sheep showmanship. Classes are based on the grade of the exhibitor as of the day of the show. Divisions are as follows:

Pre-Junior – 2<sup>nd</sup> Grade and under  
Junior – 3<sup>rd</sup> – 6<sup>th</sup> grades  
Intermediate – 7<sup>th</sup> – 9<sup>th</sup> grades  
Senior – 10<sup>th</sup> – 12<sup>th</sup> grades  
Overall Sheep Showmanship Award

## **BREEDING EWE**

Nomination Process: All Ewes must be owned by November 9, 2022. All Ewes will be nominated at the Creek County Fairgrounds on November 9, 2022. If nominating at OYE, please use the OYE tag for county nomination, all others will need a county tag.

1. County Bred Classes, refer to Page 7, Rule #21.
2. All Ewes will be positively identified from registration papers and/or the Creek County Nomination Forms at the Creek County Livestock Show when they are checked in by the Sheep Committee.
3. No more than 3 Ewes may be shown by any one exhibitor.
4. All registered Ewes must have registration papers listing the exhibitor as the sole owner (No Family, Ranch, or Partnerships) at the check in during the Creek County Livestock Show.
5. The practice of “drenching” sheep is acceptable at the Creek County Livestock Show.”
6. All Breeding Ewes must be slick sheared to within ¼ of an inch.
7. There must be 3 or more registered ewes of the same breed entered and eligible on the day of the show to recognize that breed in the show. If less than 3 registered ewes, they will show with Commercial Class. All Non-Registered Ewes will show in Commercial Class.

8. Breed classes will be broken by the Sheep Committee. Registered Ewes will show by age. Ewe Lambs must have 8 temporary incisors, with no visible signs of permanent teeth. Yearling Ewes must have 6 temporary incisors and one pair of permanent incisors. Commercial Ewes will be shown by weight determined by the Sheep Committee with approximately 5 or more to each class.
9. After Champion and Reserve Champion are selected, the judge will line up as many Ewes as he/she and the Sheep Committee deems necessary for sale order.
10. A sheep exhibitor may exhibit a Ewe as Breeding Ewe or as Market Lamb; but not both. Exhibitors do not need to designate Ewe Lambs as Market or Breeding at nomination nor on entry forms.
11. Grand and Reserve Grand may make the Premium Sale by the following criteria: one ewe will make Premium Sale if 10-19 ewes are exhibited; two ewes if 20 or more are exhibited. The judge will select sale order and alternates.
12. If ten (10) or more ewes are entered in the County Bred division, the Champion County Bred ewe will be allowed in the Premium Sale as the 3rd overall ewe sold. If the Champion County Bred ewe is Grand or Reserve overall ewe, the total number of ewes in the sale will remain at two (2).

# **SWINE DIVISION**

## **BREEDING GILT**

Nomination Process: All Breeding Gilts must be owned by December 9, 2022. All Breeding Gilts will be tagged with Pseudo rabies 840 tag and ear notches read by December 9, 2022 by Ag Ed Teacher or Extension Educator. A form listing the family name for all species, breed description, ear notch, and 840 tag number must be turned into the OSU Extension Office by December 9, 2022. All Breeding Gilts must be included in this form or will not be allowed to show. Please include the 840 tag number and ear notch information with nominations.

1. County Bred Classes, refer to Page 7, Rule #21.
2. All Breeding Gilts will be positively identified from a **chipped 840 tag** at the Creek County Livestock Show.
3. No more than 3 Breeding Gilts may be shown by any one exhibitor.
4. All registered Breeding Gilts must have registration papers with proper ear notches listing the exhibitor as the owner (No Farm, Ranch, or Partnerships) at the check in during the Creek County Livestock Show. Must show papers during weighing of each breeding gilt. Ear notches will be checked with registration papers.
5. Swine exhibitors may **NOT** use any paint, dyes, oil, sheen, or any product for coat dressing on day of show. **WATER ONLY.** Any Swine inspected by the Swine Committee and found to have anything other than water for coat dressing will be disqualified.
6. All swine may be clipped at the Creek County Livestock show; however, the practice of "snaring" swine is expressly prohibited at the Creek County Livestock Show.
7. There must be 3 or more registered Breeding Gilts of the same breed entered and eligible on the day of the show to recognize that breed in the show. If less than 3 registered Breeding Gilts, they will show in the OPB class. All Non-Registered Gilts will show Commercial.
8. Commercial gilts will be officially weighed by the Swine Committee; each exhibitor is responsible for a weight card filled out for their own animal. The maximum weight of a Commercial gilt will be 350 pounds with no reweighs allowed.

9. Breed classes will be broken by the Swine Committee. Registered Breeding Gilts will be shown by age. The Swine Committee will keep class size in accordance with the Market Hog Show.
10. Grand and Reserve Grand may make the Premium Sale by the following criteria: one (1) gilt will make Premium Sale if 10-19 gilts are exhibited; two gilts if 20 or more are exhibited. The judge will select sale order and alternates.
11. If ten (10) or more gilts are entered in the County Bred division, the Champion County Bred gilt will be allowed in the Premium Sale as the 3rd overall gilt sold. If the Champion County Bred gilt is Grand or Reserve overall gilt, the total number of gilts in the sale will remain at two (2).
12. After Champion and Reserve Champion of each breed are selected, the judge will line up as many Gilts as he/she and the Swine Committee deem necessary for a preliminary sale order.
13. A swine exhibitor may exhibit a Gilt as Breeding Gilt or Market Hog; but not both. Exhibitors do not need to designate Gilts as Market or Breeding at nomination nor on entry forms.
14. Showmanship for all Swine exhibitors will be on Friday evening. Only exhibitors that have a hog entered in their name and exhibited by the owner are eligible. (If you just show a hog that belonged to someone else, you CANNOT compete in swine showmanship.) Classes are based on the grade of the exhibitor as of the day of the show. Divisions are as follows:

Pre-Junior – 2nd Grade and under  
Junior – 3rd – 6th grades  
Intermediate – 7th – 9th grades  
Senior – 10th – 12th grades  
Overall Swine Showmanship Award

If you want to go to Oklahoma Youth Expo you must be at least 8 years old, in the 3rd grade and win showmanship division for swine.

## MARKET HOG

Nomination Process: All Market Hogs must be owned by December 9, 2022. All Market Hogs will be tagged, and ear notches read with a Creek County Tag by December 9, 2022 by an Ag Ed Teacher or Extension Educator. A form listing the family name, breed description, ear notch, and 840 tag number must be turned into the OSU Extension Office by December 9, 2022. All Market Hogs must be included in this form or will not be allowed to show. Please include the 840 tag number and ear notch information with nominations.

1. County Bred Classes, refer to Page 7, Rule #21.
2. All Market Hogs will be positively identified from a **chipped 840 tag** at the Creek County Livestock Show.
3. No more than three (3) Market Hogs may be shown by any one exhibitor.
4. Swine exhibitors may **NOT** use any paint, oil, sheen, or any product for coat dressing on day of show. **WATER ONLY.** Any Swine inspected by the Swine Committee and found to have anything other than water for coat dressing will be disqualified.
5. All swine may be clipped at the Creek County Livestock Show; however, the practice of “snaring” swine is expressly prohibited at the Creek County Livestock Show.
6. The Swine Committee will designate a classifier to classify market hogs during weigh in. All Market Swine should meet classification guidelines for breed character as outlined in the 2023 OYE Rule Book. Any swine not making their breed characteristics will be placed into the crossbred class. The classifier decision will be final.
7. Market Hogs must weigh between 200 and 290 pounds during weigh in. One reweigh will be allowed only on Market Hogs over 290 or less than 200 pounds. No Market Hogs weighing less than 200 pounds, or more than 290 pounds will be allowed to show. All Swine will be officially weighed by the Swine Committee; each exhibitor is responsible for a weight card properly filled out and bringing their animal to the scales. Gilts that are over or under the weight limits **will be** allowed to show in the Breeding Show. The animal’s actual weight will be what is used to break classes. The animals will not be reweighed during the show. Market hogs will be called and weighed by breed (same order as show day).
8. The Swine Committee will break the classes. There will be no fewer than 22 classes and no more than 30 classes of Market Hogs. If there are 8 classes or more in a breed, then they can be split into 2 divisions.

9. To determine if there are enough swine to have a breed eligible for the premium sale, the total number of Market Hog entries will be divided by 44 and rounded to the nearest whole number will equal the minimum number of head for that breed to be eligible for premium sale. If less than that number but having 3 or more, that breed will show for trophies only. The champion will then show for sale order with the crosses. If a breed has less than 3 entries, they will show with the crosses.
10. There will be 44 Market Hogs in the Premium Sale. 44 divided by the total number of head entered the day of show will determine the percent of each breed eligible to make the sale. The judge will select the number of sale animals per breed based on quality. NOTE: When there is more than one class per breed, a first-place pig is not guaranteed in the Premium Sale. Final Premium Sale order will be determined by the Fair Board based on the number of animals in each breed and final breed placing. If there aren't enough entries in 2 or more breeds to meet the minimum number required to make a breed, they will be combined in an OPB class. If the total number of entries in the OPB class meets the minimum number required to have a breed they will be allowed in the Premium Sale.
11. After Champion and Reserve Champion of each breed are selected, the judge will line up as many Market Hogs as he/she and the Swine Committee deems necessary for the Sale Order and alternates. If animals are not at the ring by the third call, they will be dropped, and the next lower placed animal will be called.
12. A swine exhibitor may exhibit a Gilt as Breeding Gilt or Market Hog; but not both. Exhibitors do not need to designate Gilts as Market or Breeding at nomination nor on entry form.
13. Showmanship for all Swine exhibitors will be held on Friday evening. Only exhibitors that have a hog entered in their name and exhibited by the owner are eligible. Classes are based on the grade of the exhibitor as of the day of the show. Divisions are as follows:

Pre-Junior – 2<sup>nd</sup> Grade and under  
Junior – 3<sup>rd</sup> – 6<sup>th</sup> grades  
Intermediate – 7<sup>th</sup> – 9<sup>th</sup> grades  
Senior – 10<sup>th</sup> – 12<sup>th</sup> grades  
Overall Swine Showmanship Award

If you want to go to Oklahoma Youth Expo you must be at least 8 years old, in the 3<sup>rd</sup> grade and win showmanship division for swine.

# **AG MECHANICS CONTEST**

**AG Mechanics Committee: Terry Spencer, Jeff Gilbert, Noah McGinnis and Dylan Johnston**

## **Eligibility**

1. All team members must be a member of a Creek County 4-H Club or FFA Chapter. The projects must have been constructed by 4-H and FFA members that are listed on the entries, with photography throughout the construction process to serve as proof.
2. All projects may only be exhibited one (1) time at the Creek County Livestock Show. Only projects completed after the previous year's Oklahoma Youth Expo are eligible for exhibition.
3. Each exhibitor or group may enter up to five (5) projects; no more than one (1) per division. Exhibitors may not enter both a group and an individual project per division; if a team project is entered, all individuals on the team would be the maxed for the division. If a club has a team in the division and another individual who is not on the team would like to enter into the same division, they can.
4. A group of exhibitors shall not exceed four (4) students showing the project for a team.

## **Entries**

The entry fee is \$25. Entries must be turned in to The Creek County Extension Office by Friday, January 20, 2023. Projects may have been constructed by an individual or a group and may be individually or chapter owned. All projects must be entered in the names of the exhibitors who participated in the planning and construction of the project. Substitution of exhibits is not allowed.

## **Showmanship**

1. Exhibitors shall be dressed in official 4-H or FFA show attire. This attire is outlined under "Exhibitor Dress Code" on page 7 of this rule book.
2. Exhibitors must be present at the projects throughout the entire time the judging is taking place.
3. Exhibitors should be prepared to answer questions the judges may have about their project.
4. Exhibitors should be prepared to assist the judges in any measuring or other evaluation techniques if they are asked to do so. (Holding tape measure, multimeters, flashlights, etc.)

## **Presentation**

1. Teams should indicate to the judges which team member served as lead engineer and welder of the project. This will allow the judges to ask specific questions to these individuals. All team members may present, but it is the responsibility of the team to specify which team members worked on specific areas of the project.
2. All projects should be complete including finish. Any item, necessary for use of the project, must be a part of it (example: hinges and latches on gates and panels, lift pins, hydraulic hoses on tractor equipment, etc.), including documentation.
3. All projects must be painted or properly treated and must be clean and in a presentable condition, even though they may have been used. No touch up painting of ANY type will be allowed inside the exhibit area.
4. Electricity may not be available for computers or other electronic devices. An effort will be made to provide electricity for projects requiring it for operation during judging only. It is the responsibility of exhibitor(s) to plan for this, and to provide any electrical equipment (generators, batteries, extension cords, etc.) they may need.
5. Tractors, trucks or other vehicles (including non-entered trailers) are not allowed in the exhibit area as part of the display. If the project is permanently attached, please contact staff or superintendents for ruling.

## **Documentation**

A portfolio that includes the following: original (exhibitor created) plan or drawing, a bill of materials, construction log, and no more than 20 photographs showing all phases of construction/restoration (plan, bill of materials and photos not to exceed 6 pages, and may be two sided), and marketing flier (1 page) are to be provided with the projects. ODOT regulations and specifications are to be provided as they apply to individual projects. Display of plans, photos, etc. must be done in such a manner that no additional floor space is required. Stands, podiums, etc. will be permitted.

1. Portfolio: The original (exhibitor created: hand drawn or digitally created) plan or drawing, a bill of materials and photographs showing all phases of construction/restoration should be bound together via binder or folder. Portfolio total should not exceed 6 pages, two-sided (may include an additional cover page but is not required). Marketing flier should also be included for a total of 7-8 pages. Exhibitors may use their discretion on this part of the documentation but all of the above must be included.
2. Marketing Flier: Each team will develop an 8.5" by 11" one-sided flier promoting and detailing the product. The flier should be designed to be utilized as an advertisement and an overview of the product to be shared with customers.

## **Safety on the Fairgrounds**

1. General Safety – Appropriate and safe display stands must be provided for gates, panels and other projects that need support. Sharp edges and points, such as found on self-feeder roofs, bale movers, etc. are to be padded or covered as necessary to prevent injury. Flammable and/or combustible liquids shall not be used, stored or sprayed inside any building at any time. This shall include, but not limited to, enamel paints, thinners, reducers, gasoline or any other petroleum-based liquids. All liquids must be in properly labeled original containers. All compressed gas cylinders shall be properly secured. Hand wheels are to be removed. Protective caps installed and taped. No regulators or hoses are to be installed at any time.

2. Trailer Safety – All trailers and other equipment to be operated and/or transported on public roads are to be equipped with safety equipment specified in Oklahoma Statutes. All towed equipment, regardless of standards, is to be equipped with safety chains. All three-point hitch and power take off (PTO) operated equipment are to meet current ASABE Safety and dimension standards.

3. Electrical Safety – All 120 VAC and higher electrical plugs and receptacles must be grounded. Ground Fault Circuit Interrupters (GFCI) shall be required for all 120 VAC receptacles. All electrical connections are to be protected in appropriate indoor or outdoor rated enclosures.

4. Projects with Engines – There is to be no more than five (5) gallons of fuel in any fuel tank. Fuel cap taped closed and secure against tampering. Disconnect all batteries. No vehicle and/or equipment refueling inside the building.

**Failure to provide all required documentation and information will result in docked points.**

**Superintendent's will have final say in classification and may designate projects for a different division, other than the one they had entered.**

## **ACADEMIC ELIGIBILITY**

1. Creek County Fair Board will follow Oklahoma Secondary Schools Athletic Associations (OSSAA) rules for academic and behavioral guidelines to determine eligibility to participate in the Creek County Livestock Show.
2. Youth who have been declared ineligible to participate in extra-curricular activities by their local school administration will be declared ineligible to participate in this show.
3. Youth who are eligible on the first day of the show will be considered eligible through the duration of the show. Similarly, youth who are ineligible on the first day of the show will be considered ineligible through the duration of the show.
4. If an exhibitor is ineligible to participate in the show for any reason, including rules of the Oklahoma Secondary Schools Activity Association, the animals owned by the exhibitor are also ineligible for the show.
5. Ineligible youth who participate in the show will forfeit all show, and/or sale premiums and awards; and will be subject to disciplinary action as provided by the local school policies.
6. It will be the responsibility of the local school administration to notify the show management if a particular student is ineligible to participate.
